Atlantic Region Freight Rates

This announcement which, I think, had been expected for quite some time will doubtless constitute an incentive for all members of our forces in addition to filling them with pride for receiving an award from their country.

Until now, the decoration which had been awarded came from a foreign country, and only a handfull of Canadian servicemen or civilians could hope for their galantry being recognized by their country.

We dare hope that this decoration which the right hon. Prime Minister has just announced will be awarded not only to servicemen who deserve it fairly often through their galantry on the line of service in time of war, but also to many deserving civilians in the accomplishment of their duties. I think particularly of policemen and firemen, as well as a number of persons who, at one time or another, are called by their duties to take actions which deserve to be recognized.

Given the decorations that our country proposes to grant, I hope that a greater number of worthy persons will see their heroic deeds recognized.

## **INDIAN AFFAIRS**

PAYMENT OF EXPENSES OF DELEGATION—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43

Mr. Frank Howard (Skeena): Mr. Speaker, I rise pursuant to Standing Order 43 to move a motion because of urgent and pressing necessity. That necessity is occasioned by the arrival yesterday in Ottawa of a committee of native Indian people from Thunder Bay who came here at their own expense as a result of an agreement that they would be able to have a meeting yesterday afternoon at five o'clock with the Minister of Indian Affairs and Northern Development (Mr. Chrétien). That meeting did not proceed because of an error on the part of the department. Therefore I seek the unanimous consent of the House to move, seconded by the hon. member for Comox-Alberni (Mr. Barnett):

That this House hereby authorizes the Department of Indian Affairs and Northern Development to reimburse the committee of Indian people under the joint leadership of Mrs. Monica Turner, chairman of the Ontario Native Women's Association and Mr. Bill Sault of the Treaty Research Department of the Union of Ontario Indians, who travelled from Thunder Bay to Ottawa to meet with the Minister of Indian Affairs and Northern Development and who incurred expenses of a personal nature for that meeting which could not take place because of an error within the said department.

Mr. Speaker: The hon. member might recognize that this is a motion which should perhaps have been preceded by a Royal recommendation. In any event, so as not to get involved in this rather subtle aspect of the matter, I would invite hon. members to indicate whether there is unanimous consent to the motion proposed by the hon. member.

Some hon. Members: Agreed.

Some hon. Members: No.

Mr. Speaker: There is not unanimous consent and the hon. member's motion cannot be put at this time.

ATLANTIC REGION FREIGHT RATES—REQUEST FOR UNANIMOUS CONSENT TO MOVE MOTION UNDER S.O. 43
