VIET NAM—PROPOSED INQUIRY INTO FAILURE OF EMBASSY TO EVACUATE VIETNAMESE MEMBERS OF STAFF—MOTION UNDER S.O. 43

**Mr. James A. McGrath (St. John's East):** Mr. Speaker, I rise under the provisions of Standing Order 43 on a matter of urgent and pressing necessity concerning the deplorable stance assumed by the Canadian government in its refusal to expedite the evacuation of the Vietnamese employed by its embassy in Saigon on the premise that exit visas were unobtainable. In light of the successful efforts on the parts of both Pan-American Airways and the British embassy in Saigon to evacuate Vietnamese members of their staffs, I move, seconded by the hon. member for Hamilton West (Mr. Alexander):

That the government order an immediate parliamentary inquiry into the failure of the Canadian Embassy to evacuate its Vietnamese staff.

SUGGESTED REDUCTION OF MORTGAGE INTEREST RATE TO STIMULATE CONSTRUCTION—MOTION UNDER S.O. 43

PROPOSED INQUIRY INTO BANKING PROCEDURES OF CIDA—MOTION UNDER S.O. 43

That the government order an immediate inquiry into the banking procedures of CIDA and other government agencies to see what other sums of Canadian taxpayers' money have not been earning interest over long stretches of time.
