PRECEDENT ESTABLISHED IN 1967

Hon. Erik Nielsen (Leader of the Opposition): Madam Speaker, I am glad that the Acting Prime Minister mentioned precedents. I am going to ask him to take to the Prime Minister, when he reports on his activities in the discharge of his duties on this day, the record of a former Prime Minister, the late Right Hon. Mr. Pearson, a gentleman who had a higher degree of respect for the traditions and practices of this place than the present Prime Minister. Will the Minister convey the precedent to the Prime Minister of the resignation on September 18, 1967, of the then sitting Member for Colchester-Hants, Mr. Cyril Kennedy, and on the same day, September 18, 1967, a warrant was issued to the Chief Electoral Officer, and the day after that warrant, the then Prime Minister announced that the writ for the by-election was issued. That will all be found in *Hansard* for September 25, 1967.

An Hon. Member: What is your question?

Mr. Nielsen: My question is: will the Acting Prime Minister convey that very useful precedent, which was established by a gentleman who was far more familiar with the practices and precedents of this Parliament?

Hon. Jean-Luc Pepin (Minister of Transport): Madam Speaker, obviously the Leader of the Opposition is trying to create a tempest in a teapot. I was here yesterday. The Prime Minister mentioned "one or two weeks". He mentioned "soon". I did not see anything particularly alarming in the statements which he made at the time. However, if my hon. friend would like to give me a copy of the note from which he was reading, I will gladly communicate it to the Prime Minister who might be impressed, who might be influenced, and who might not have to do that particular research if someone else already has done it.

VOLUNTARY ORGANIZATIONS

DEFINITION OF CHARITABLE ACTIVITY

Mr. Walter McLean (Waterloo): Madam Speaker, my question is directed to the Secretary of State. On June 21 an article in *The Globe and Mail*, following last week's conference on Canadian lobbying efforts in Washington, reported as follows:

On the acid rain issue, foreign service officers in our Washington Embassy have worked with U.S. environmentalists and other interest groups, treading the fine line between diplomacy and advocacy.

As the Secretary of State will know, existing regulations here in Canada provide that any Canadian charitable or voluntary agency considered by the Government to be lobbying public opinion can lose its charitable status. The Minister made a commitment in the House to review this issue by a task force—

I have said a number of times, both inside and outside the House, that one of the key elements of a comprehensive policy to help charitable organizations in Canada was to ensure that the Canadian tax system and our legislation reflect the concerns of contemporary society. In this connection, my colleague, the Minister of National Revenue, is continuing a study of the present tax laws so that if amendments are necessary, they will be tabled in the House and we shall be able to reflect the concerns of Canadian communities in our legislation.
