What is the name of the present (a) Director (b) Deputy Director of the Keele Street Centre, Toronto and, in each case (a) for how long has he/she held the position (b) what position did he/she hold previously (c) what is his/her salary level (d) what formal education does he/she have?

Hon. Bob Kaplan (Solicitor General of Canada): In so far as the Correctional Service of Canada is concerned:

A. There is no Director at Keele Street Centre but there is a Superintendent, whose name is Anthony Lombardo. (a) Date of appointment to present position: September 1, 1980. *(b) Position held prior to present appointment: Assistant Warden, Administration, Warkworth Institution, Campbellford, Ontario. (c) Salary range: \$28,118 to \$31,640. *(d) This position requires a university degree, preferably with specialization in sociology, psychology, social work, criminology or some other specialty relevant to the position, or to have passed the Public Service Commission Examination, "General Intelligence Test 310" and possess the experience qualifications for the position.

B. There is no Deputy Director at Keele Street Centre but one of the four Parole Officers, Allan Beauvais, is presently designated by the Superintendent to act in his absence through
