If I may, in order to shed some light on the issue reads to read a communication into the record. It goes as follows:

Dear Mr. Speaker:

I have recently become aware that officials of my department issued a letter to a number of townships and municipalities in Northern and Eastern Ontario, the contents of which, were inappropriate given that the letter failed to reflect the status of bill C-62 respecting the proposed goods and services tax.
