# VIOLENCE AGAINST WOMEN IN CANADIAN SOCIETY

DEBATE ADJOURNED

Hon. Royce Frith (Deputy Leader of the Opposition) rose pursuant to notice of Tuesday, February 13, 1990:

That he will call the attention of the Senate to the issue of violence against women in Canadian society.

He said: Honourable senators, this inquiry draws the attention of the Senate to the issue of violence against women in Canadian society.
