CANADIAN CURRENCY IS ON FIRM BASIS

TO JOIN FORCE

OTTAWA, Jan. 12.—Hon. W. T. White, minister of finance, today gave a state-ment regarding increase of about \$48.4 MO00000 in Dominion note circulation since the outbreak of war. He said that, apart from notes issued against securities, gold to the amount of 62 per cent, was held against the remain-ing outstanding circulation. It was not until 1002 that the percentage of gold so held rose to 60 per cent. Dominion notes aggregating about \$25,000,000 have been issued since August, chiefly against the deposit of Dominion, Dominion-guaran-teed and municipal securities. 





No less than 127 men were guests of the police last night/at the various stations. Claremont and Markham street sta-tions had the largest number, there being 41 at the former and 27 at the latter. Inspector Geddes of Agnes street station reports that there were 903 men who applied for dinner and 984 who applied for supper at the House of Industry gesterday.
