Mr. HENDERSON. As this Bill will come up to-morrow during the hour for private Bills, I shall give notice to-night of an amendment to strike out clause 14, but if we have an assurance from the minister that it will not come up to-morrow, I will consider my amendment more fully.

Sir WILFRID DAURIER. It may come up.

Mr. HENDERSON. If the minister will guarantee that it will not come up, I will defer my notice of amendment.

Mr. GRAHAM. I imagine it will not be taken up, but my hon. friend might as well put in his notice, because a little inconvenience to a private member might serve the convenience of the whole House.

Mr. COCKSHUTT. Is it possible for members to obtain copies of these Bills as they are read from the chair? Where amendments are made in this way it is impossible to follow their meaning by one reading from the chair.

Mr. FOSTER. There is a good deal in what my hon. friend says. We cannot all attend the Railway Committee, and therefore we do not know what has taken place. A conscientious member reading over these Bills the night before they come up in the House does not know of the amendments made in committee, and may find when he comes here that several sections have been added to a Bill. The cost of printing the amendments would not be great, and then each member would have in his file of Bills everything that it is proposed to bring before the committee.

Mr GRAHAM My hon, friend is right. I certainly thought that it was the rule that these Bills were reprinted, and I am heartily in sympathy with my hon, friend's view. We cannot discuss the Bill properly unless we have the reprinted Bill before us.

Mr. WM. WRIGHT. I wish to refer to a matter connected with this Bill which might be taken into consideration now or before it is reprinted. The Bill provides for very wide latitude as to where the railway may reach the Pacific coast. Apparently it may find an outlet anywhere. I think that should be specified more particularly and the promoters of the Bill might have that arranged before it comes up again.

Mr. GRAHAM. The promoter of the Bill is not here.
