PROPOSED FIRST MINISTERS' CONFERENCE TO DEAL WITH ECONOMIC PROBLEMS—MOTION UNDER S.O. 43

Mr. Lincoln M. Alexander (Hamilton West): Mr. Speaker, I rise on a matter of urgent and pressing necessity under Standing Order 43. In view of the recent report of the Organization for Economic Co-operation and Development which predicts gloomy economic prospects until at least mid-June 1978, and more specifically, in view of its forecast saying that business investment will remain weak, the gross national product will rise about 3 per cent, unemployment will remain high and heavy inflation will continue, and in view of the OECD's prediction that economic recovery could accelerate in the first quarter of 1978 if there is an upturn in real disposable income and personal consumption, I move, seconded by the hon. member for Hamilton-Wentworth (Mr. O'Sullivan):

That the Prime Minister immediately convene a first ministers' conference to specifically deal with the problems of real growth, inflation, and high unemployment and as soon as possible thereafter cause a new budget to be introduced which provides for at least tax cuts for low and middle income wage earners.
