was subjected to a vigorous cross-exam
ination by E. A. Powell, during which
he broke down and cried. He admitted
giving his name as John Friday when
asked at No. 6 table, but his evidence in
general was a denial of the allegations
made by the prosecution.

He said that his name was Arthur
Warren, but that John James was his
sea cognomen, as he was sailor. He
went into the marking booth opposite No.
5 table with two others, and was ordered
out by Returning Officer Murdoch. As
he was going along he heard somebody
say "stop those men." He was brought
back to No. 6 table and was asked his
name. In his excitement he replied
"John Friday." He said he did not want
to vote.

One man looked at the voters' list and
they wanted to swear him, but he re
fused. Two or three then shouted to
have him arrested, and he was taken into
custody. He did not apply for a ballot
paper in the name of John Friday, or
any other name. When taken to the
table he did not resist, and in fact was
endeavoring to get out of the place al
together when stopped by Mr. Powell, he
said he arrived in Victoria eight months
ago, and had been to sea. He had been
recently. When he saw his chest enter
the polling booth he followed them. They
did not tell him what they were going to
do. He had had no conversation with
any one about voting previous to that,
and did not know who the candidates
were. No one asked him to go in.

He knew where Col. Prior's committee
room in the market was, but had not
been in it. The card found on him was
given him on Caulfield street by some
one he didn't know, and he took it out of
curiosity and put it in his pocket. The

Unbusiness Caused by Suspension in
Business—Mr. Carpe Goel to
Tacoma.

In consequence of the decision rendered
by Judge McGee in Minneapolis, pro
mounging the plan and management of
the Tontine Savings Association fraudu
lent and as the same time forfeiting the
charter of the company, shareholders in
this city are to-day speculating on the
amount, if any, of their loss. Many have
been paying enormously into the associa
tion, and those who first drew money out
as a rule invested more extensively on
the second offering. A number of local
business men were paying at the rate of
more than \$50 a week in premiums.

Frederick Carme, the local agent of the as
sociation, left for Tacoma by last even
ing's steamer, where he will confer with
the agent of the association in that city.
Before his departure he was unable to
state what action will be taken by the

company. He attributed the whole
cause of the trouble to an employee of
the association who had been discharged,
and who has heretofore given consider
able annoyance.
