

AIRMAN WHO DEFIED DEATH HAVE COMMONPLACE ENDS

One of Britain's Great War Pilots Who Survived Innumerable Accidents, Catches Cold and Another Falls from a Window of His Chocolate Factory.

London, Jan. 22.—Two famous British airmen, noted as stunt fliers and war pilots by the trinity of fame, met death this week through causes far removed from their dangerous calling. M. G. Smith, who before the war was one of the champion trick aviators at Hendon, was killed at Hendon on Sunday when he fell from the window of his place of business. He once held the loop record and was a flying instructor during the war. Recently he had been conducting a chocolate factory.

Group Captain Alan "Jack" Scott, who during the war lived an "Odyssey of hardship," was buried today. He caught cold while on a visit to St. John and pneumonia ensued. Capt. Scott was one of the greatest British

war pilots, although he was practically unknown to the general public. He had been made permanently lame by a 2,000 foot fall, but begged to be placed in active service and became a commander in the Sixtieth Squadron, with the two famous aces, William A. Bishop and Albert Ball under him. He is extolled as "the Major" by his subordinates.

Capt. Scott had survived so many accidents that it was said that practically no part of his body was unscathed. Lately he had been secretary to the Air Ministry. Among the mourners were a large number of members of the Royal Air Force as well as Lord Birkenhead, who was Capt. Scott's personal friend and called him the bravest man he had ever known in or out of fiction.

In consequence of Mr. Lloyd George's intention to attend both the French and Italian prime ministers will also be present, thereby giving the meeting the utmost measure of importance.

In the first place the Moscow Government intimated that it was not considered safe for her representatives to proceed to Genoa on account of Russian activities.

It is pointed out that a Russian delegation in connection with the Russo-Italian trade agreement has been in Rome for some time, where there are less than 500 fascists, and only on one occasion has there been any sort of demonstration against the Soviet representatives.

There are also unofficial demands appearing through the intermediary of the Soviet press, to the effect that the Soviet Government desires to bring the matter of Russian debts up at the Genoa conference. The claim is being made that foreign powers should offer compensation for the losses caused by Russia through foreign intervention.

Likewise payments for seizure made by General Wrangel, General Denikin and Gen. Nicholas Zdenitsch.

The first aim of these efforts was directed toward changing the venue of the conference from Genoa to London, where, according to the Russian mind, the atmosphere is distinctly more favorable to their interests. Having failed in that, an effort is being instituted to open a controversy on the justice of the allied demands that Moscow should recognize former Russian debts as preliminary to any international financial aid.

Russia has been invited to attend, and the sincerity of her original acceptance is considered a clear indication that a firm attitude by the Allies will soon cause her to drop pretended stipulations.

The march of political events at Genoa, it is expected, will soon show where British and French interests run counter to one another in the matter of Russian and German reconstruction. For this reason alone, it is considered desirable that the greatest number of European countries should be represented, as well as the United States and Japan.

Reconstruction of Europe.

Great Britain has nothing to hide, and is perfectly frank in her desire to see Russia and Germany set on their feet, both for their own good and very necessary for the betterment of British trade—a primary effect of which would be the relief of the deplorable

Debate Ends On Dyer Anti-Lynching Bill

Mondell Convinced Effective Measure Will Be Enacted.

Washington, D. C., Jan. 21.—General debate on the Dyer anti-lynching bill was finished by the House today, and the measure will come up in a few days for amendments. That amendment tending to kill the bill will be introduced by Southern Democrats is certain. It seems equally certain they will be rejected.

During the debate considerable opposition developed to the provision for the imposition of a fine of \$10,000 on a community in which a lynching took place. It was pointed out that innocent communities thus might become the victims of the lawbreakers from a distant point, as frequently lynchings took place far from the scene of the original crime or the place where the prisoner had been held.

Floor Leader Mondell said today the friends of the bill are ready and willing to accept sane and sensible amendments, but all drastic propositions will be turned down by the House. He is firmly convinced that an effective and reasonable anti-lynching law will be enacted.

Strong Sermons At Charlotte St. Church

Rev. C. R. Freeman Begins His Pastorate With Large Congregations at Baptist Church

Rev. C. R. Freeman, M. A., began his pastorate at the Charlotte street Baptist Church, yesterday, and large congregations were present at both services to welcome their new minister. Rev. Mr. Freeman comes to the church with an enviable record of successful pastorates and the church under his able leadership may look for an even greater prosperity than it has enjoyed in the past.

Mr. Freeman is a native of Milton, N. B., and received his early education in the public schools of his native town. At the age of sixteen he moved to the United States and for three years was in the employ of his uncle, Ramsey Bros., shoe manufacturers of Lynn and Manchester, Mass., where he obtained a valuable business training. On deciding to enter the ministry, he sought further scholarly equipment which he obtained at Clarkson University, Potsdam, N. Y., and University and Rochester Theological Seminary, graduating from the latter in the class of 1900.

He held large pastorates in Bridgeport, Ayerston and Chasco, N. B., for the past five and a half years at Charlotte street, P. M. L. He has always been regarded as one of the strong men of the denomination and for the years 1917-18 was president of the Maritime Convention, and for the same two years was president of the Ministerial Association of Charlotte street.

Before leaving for St. John, Mr. Freeman was presented with an address and purse of gold by the congregation he was leaving. Mrs. Freeman was remembered by the Ladies Aid of the church and the choir.

At the morning service the subject of Mr. Freeman's address was the "Ministerial Union." His text was taken from Mark 16:45: "For even the Son of Man came not to be ministered unto, but to minister and to give his life a ransom for many."

Christ came into the world not to be ministered unto, but the highest point in his career was the giving of his life as a ransom for many. The church must not lose sight of this fact and must be a life work and not a mere profession.

SOVIET RUSSIA PROPAGANDA ON RELIEF WORK

Reds Impute Politics to Relief Administration—Workers Act as Liaison Officers.

London, Jan. 21.—A bold statement by a responsible attaché of the Soviet Government headquarters here today to the effect that "we know the American Relief Administration personnel are acting as liaison officers in Russia between the Soviet and the United States Government" caused considerable surprise and brought a quick denial from the Relief Administration headquarters.

The statement was made to your correspondent during a conversation in which an effort was being made to clear up some criticisms appearing in the American press to the effect that while the administration was doing much good work in feeding the people, nevertheless it was not keeping its hands entirely free from politics, or at least what might be interpreted as an attempt at economic penetration.

While the Russian officer was quite emphatic in his remarks to your correspondent, efforts to elucidate them were futile in that he declined to state specifically in what manner the personnel was acting as liaison representatives, just what they were doing or how they were doing it. The information he said, had come to him through a trusted member of the Soviet Government, who had just arrived from Moscow, but for some reason he failed to provide the all-important details to back up such a declaration.

At the Relief Administration headquarters the statement was characterized as absurd, but as it came from the Soviet headquarters, Walter Lyman Brown, director of the Relief Administration in Europe, answered by saying:

Relief Their Sole Objective. "Our job in Russia is to feed the

people and to provide seed grain, and we are doing it to the fullest extent of our facilities. We have no connection with the United States Government and only work with the Soviet to the extent of obtaining their help in our work. There is only one of our men in Russia who is not working entirely on the feeding programme, and he is carrying out one provision of the Riga treaty—getting American citizens out of Russia.
