- 7. The work of the planning group was completed when zoning was inaugurated on May 1, 1969.

- 1. Is the postal zone system which was in force in Vancouver on January 1, 1969 now in force?
- 2. Is the 3 digit postal zone system which was to go into use in Vancouver on June 15 now also in effect?
- 3. How many postal zone books outlining the new 3 digit postal zone numbers for Vancouver were distributed?
- 4. When were these books first given out and when did the Post Office Department stop distributing them?
- 5. How much did these books cost the Post Office Department?
- 6. Did the Post Office Department renumber the postal zones of addresses on mailing lists for Vancouver destinations and at what cost to the Post Office Department?
- 7. When was the campaign advertizing the new 3 digit postal zones in Vancouver first put into effect and when was this advertizing discontinued?
- 8. How much did this advertizing campaign cost?

  9. For how long is it estimated that Vancouver will continue to have two overlapping postal zone systems?
- 10. Is the Post Office Department suggesting that clients now using the 3 digit postal zone system might revert to the system formerly in use?

- 7. No direct advertising campaign was conducted. The Vancouver Post Office requested local mailers to have their mailing lists rezoned.
  - 8. No direct cost.
- 9. Until the study of the possible use of a postal code in Canada, now being organized, is completed and its results and recommendations are evaluated.
- 10. No. Customers are told they may use either zoning system.
