## Temporary Loan Act, 1866.

IV. All Debentures made out and issued under this Act shall be according Form of feben. tures and apon what Fand Chargeable with what exception. to the Form set forth in the Schedule to this Act annexed, and shall bear date on the Day of the Issuing thereof, and shall be Numbered in regular Arithmetical Progression commencing with the Number One, and all such Debentures so issued shall be entered by the Auditor of the Colony in a Register to be called the "Debenture Register, 1866," and such Debentures shall be deemed a Charge upon the General Revenue of the Colony subject always to the Vancouver Island Road and Harbor Loan Act, 1862, and to such other existing Charges as are now by law imposed. Governor to anthorize Treasurer to pay V. It is further enacted that the Governor shall authorise the Treasurer to pay the said Debentures and the Interest thereon out of the General Revenue Peben ures out of the Colony when such Debentures and Interest shall have fallen due, subject Revenue. always to the Charges on the General Revenue hereinbefore enumerated in the last preceding Section.

Transfer of Debeatures,

VI. The Debentures as aforesaid and the Interest which may have accrued thereon shall be payable to the Holder or Bearer of such Debentures, and such Debentures may pass by delivery only and without any Assignment or Endorsement, and the Holder of every such Debenture for the Time being shall have the same Rights and Remedies in respect thereof as if he were expressly named thereon.

VII. Any Person who shall Forge or Alter, or who shall Offer, Utter, or Dispose of or Put Off knowing the same to be Forged or Altered any Dehenturé purporting to be made out and issued under this Act shall be guilty of Felony, and being thereof convicted shall be Imprisoned for any Period not exceeding Three Years with or without Hard Labor at the Discretion of the Judge before whom any such Person shall be tried and convicted.

VIII. It shall be lawful for the said Governor at any Time to anthorise the Treasurer to Re-purchase any Debenture made out and issued under this Act, and all Debentures so Re-purchased shall be forthwith cancelled and destroyed, and no Re-issue of Debenture shall be made in consequence of such Purchase and destruction.

IX. The Proceeds of the Sale of the said Debentures shall be paid into the General Revenue for the Use of Her Majesty, Her Heirs, and Successors.

X. This Act may be cited for all Purposes as "The Temporary Loan Act, 1866."
