## CAP. XVI.

An Act to incorporate the Upham Agricultural Society.

Passed 30th April 1851.

THEREAS John Hagarty, John Titus, James Titus, Jonathan Titus, Preamble. 'Ammon Fowler, Weden Fowler, James R. Fowler, Richard Bick-ford, Humphrey Smith, Adam Marchbank, William Sherwood, William Scott,

'Nicholas P. Wannamak, and other inhabitants of the Parish of Uphan., in ' King's County, have formed themselves into a Society for the promotion of the ' science of Agriculture in the said Parish; and it would be more beneficial to the

' interests of the Society, and enable them more effectually to carry out the inten-' tions and promote the objects thereof, if the said Society were incorporated;'

I. Be it therefore enacted by the Lieutenant Governor, Legislative Council and Company incorporated by the name Assembly, That John Hagarty, John Titus, James Titus, Jonathan Titus, Ammon of The Upham Fowler, Weden Fowler, James R. Fowler, Richard Bickford, Humphrey Smith, Agricultural Society. Adam Marchbank, William Sherwood, William Scott, Nicholas P. Wannamak, and all such persons who may now or may hereafter be admitted members of the said Society, their associates and successors, be and they are hereby erected into a Body Corporate, under the name and style of The Upham Agricultural Society, for the purposes of promoting and encouraging Agriculture, rural and domestic economy and industry within the said Parish, and shall have and enjoy all general powers incident to Corporations by Act of Assembly of this Province.

II. And be it enacted, That there shall be a general meeting of the said Society Annual meeting to or Corporation to be annually holden on the third Saturday in October in each Saturday in October and every year, at James Wannamak's, in the said Parish of Upham, at which bearers shall be annual meeting there shall be chosen one President, two Vice-Presidents, a Trea-chosen. surer and Secretary, who shall continue in office for one year, or until others are appointed in their room, in the choice of which each member of the said Corpo-

ration shall have one vote for each of the aforesaid offices.

III. 'And whereas at a general meeting of the members of the Society hereby Office bearers 'incorporated, one President, two Vice-Presidents, a Treasurer and Secretary be the office bearers were elected by the votes of the said members for the current year; Be it there- chosen. fore enacted, That the said officers so elected as aforesaid are hereby declared to be the officers of said Society or Corporation until the third Saturday in Octoher next, or until others are chosen in their stead.
