The records of the Department of the Secretary of State disclose that Edwin Wood, formerly of Britton, South Dakota, was naturalized at Weyburn, Saskatchewan, on 15th January, 1917, under the Naturalization Act, R.S.C. 1906, chapter 77. By the provisions of that act, all his minor children who were residing with him in Canada are deemed to be naturalized British subjects.
