#### NATIONAL REVENUE-SEIZURES

1. Of the seizures made by the Department of National Revenue, customs branch, from January 1, 1946, to December 31, 1946, what was the quantity of (a) cigarettes; (b) tobacco; (c) liquor; (d) other commodities, and what was the value of each?

- 1. No statistics are kept and to answer the question would entail drawing 4,482 files, the number of customs seizures for the calendar year 1946. It would take at least six weeks to compile such a statement.
- 2. (a) Cigarettes: destroyed in those cases where persons involved refuse to take release on payment of amount demanded.
  - (b) Tobacco: same as above.

(c) Liquor: destroyed.

- (d) Other commodities: sold by tender when release not taken on terms offered.

# Mr. MARTIN:

- 1. The Dominion Council of Health was established under the Department of Health Act, 1919, to consist of the Deputy Minister of National Health as chairman, and the chief executive officer of the provincial department or board of health of each province, and such other persons, not to exceed five in number, as may be appointed by the governor in council to hold office during good behaviour for a period of three years. The council, as originally composed, was perpetuated by the Department of Pensions and National Health Act. 1928, and by the Department of National Health and Welfare Act, 1944.
- 2. No statutory provision is made regarding the selection and appointment of the five additional members on the council. However, by custom it has evolved that they are chosen to represent the following groups: English-speaking women's social welfare groups; French-speaking women's social welfare groups; Agriculture; Labour; Scientific public health.
- 3. The act provides that the council shall meet at such times and at such places as the minister may direct. Usually it meets twice a year, in the spring and in the fall.
