from these declared intentions. Indeed I hope and it remains a continuing hope that the government in the striking of a new basis for the sharing will not veer from the national average, but rather will stick to the average of the two highest provinces and use this as a yardstick when it enters into the tax sharing conference in the fall.

Very briefly, may I in one minute deal with what is rapidly developing into one of the most serious labour crises in the country. I refer briefly to two situations, the first concerning defence employees at H.M.C. Dockyard in Halifax, and the second concerning the army depot and naval magazine at H.M.C.S. Shearwater, where there is continued discrimination against certain kinds of employees.

Will you be good enough, Mr. Speaker, at the appropriate time to tell me when I should stop my remarks.

I do not propose to trace the history of the founding formula for the prevailing rates policy. It goes back to 1934 and 1935. I simply suggest that, perhaps, 30 years later it is time that the government found some other basis upon which to look at the matter of payment of hourly paid employees within the Department of National Defence throughout Canada.

Mr. Speaker: Order, please. I draw to the hon. member's attention that the time has come for him to complete his remarks.

It being 5.45 o'clock it is my duty pursuant to special order made on Thursday last to interrupt these proceedings forthwith and to put the question on the main motion. Is it the pleasure of the house to adopt the motion?
