LOCATION OF SOCIÉTÉ DES RENTES IMMOBILIÈRES (SORENTIM), QUEBEC

Question No. 2,115-Mr. Godin:

- 1. In what city of the Province of Quebec is the main office of the Société des rentes immobilières (Sorentim) located?
- 2. Does the Company hold a federal charter and, if so, when was it obtained?

Hon. Herb Gray (Minister of Consumer and Corporate Affairs): 1. The department's index does not list any company with the name "Société des rentes immobilières (Sorentim)". However, it does mention a company with a Quebec charter under the name "La Rente immobilière Sorentim Limitée". As this is a company incorporated provincially the Corporations Branch of the Department of Consumer and Corporate Affairs is not in possession of information as to its head office or its main office.

2. "La Rente immobilière Sorentim Limitée" does not hold a federal charter, but a Quebec charter.

- 3. In each instance, for the last fiscal year of operation, what was the operational budget for the institution?
- 4. What was the cost per inmate at both the Springhill and Blue Mountain minimum security institutions?
- 5. What was the cost per inmate at the same point in time per inmate at medium and maximum security institutions in Canada?
- 6. Were any other minimum security institutions closed out in Canada and, if so, at what locations and in each instance, what was the capacity of each of the institutions closed?

2. Springhill, August 1959 to September 1969, 108 inmates; Blue Mountain, July 1963 to December 1972, 60 inmates.
