Marie (Mr. Symes):

That the Canadian government break off contract relations with this corrupt corporation until all the data of Lockheed's bribery attempts are made known.

**Mr. Walter Baker (Grenville-Carleton):** Mr. Speaker, in the absence of the Prime Minister, the government House leader and the Minister of National Defence, to whose department my question relates, I address my question to whoever is the Acting Prime Minister in that ramshackle government over there.

**Mr. Baker (Grenville-Carleton):** I pulled in a lot of big fish with that one, Mr. Speaker. Yesterday the Minister of National Defence said that he was satisfied that the Lockheed Company "made no payments or commissions to any Canadian". I assume the minister was not referring to the contract the consulting firm of Reisman and Grandy Limited has to help Lockheed Limited win and hold the LRPA contract. Would the Acting Prime Minister tell the House whether, in the course of the current negotiations concerning the Lockheed contract, he or the Minister of Supply and Services received representations, directly or indirectly, on behalf of that company from Messrs. Reisman and Grandy?

**Hon. Allan J. MacEachen (Acting Prime Minister):** Mr. Speaker, I should advise the hon. member that the Prime Minister, who is presently having a meeting I believe with the Premier of Prince Edward Island, will be in the House shortly. In the meantime, I can assure the hon. member I have no information with regard to the representations he has suggested.
