CANOLA-DROP IN PRICE PAID TO GROWERS

Mr. Jack Scowen (Mackenzie): Mr. Speaker, the Saskatchewan Canola Growers Association is very concerned with the downgrading of rates paid to growers by the companies. There seems to be a slightly higher chlorophyl content in the current crop as compared to last year's. It would appear that companies buying the seed are taking advantage of the producer to the tune of from \$22 to \$35 per tonne, and even more if the elevator agent buys the seed as No. 3.

Last year 57 per cent of the crop was bought as No. 1 seed while 75 per cent was loaded in Vancouver as No. 1 seed. That is a substantial loss to the producer. The grading system has not been perfected in canola purchases. The buyer simply puts 100 seeds in a receptacle and rolls the seed. The grade is established by what he thinks is green. The Canadian Grain Commission also grades, but this is time consuming.

The Canadian Grain Commission should make a policy whereby agents-

U.S.S.R.—CHILD ALLOWED TO JOIN PARENTS OUTSIDE COUNTRY

Kaisa, who is now three years old, was being held hostage by Soviet authorities who refused permission for the child to join her parents in the West.

The world community reacted to this inhumane separation of parents and child by mounting a campaign to free Kaisa. The letter-writing campaign played an important role in bringing to bear the weight of public opinion against the Soviet Union.

We have now received the good news that Kaisa will be allowed to join her parents at last. Her case is an example to all of us of what we can accomplish if we work together, speaking out against human rights violations wherever they occur.

Let us never forget that the greatest enemy of freedom is silence and that every Member of this House has a duty and responsibility to speak out for those who cannot speak for themselves.
