The Honorable Mr. Allan, from the said Committee, reported that they had gone through the said Bill, and had directed him to report the same with certain amendments.

On motion of the Honorable Sir Alexander Campbell, seconded by the Honorable Mr. Smith, it was

The Honorable Sir Alexander Campbell presented to The House, $-\Lambda$ Bill intituded: "An Act to amend the Consolidated Statutes respecting Lotteries."

The said Bill was read for the first time.

The Honorable Sir Alexander Campbell, Minister of Justice, presented to the House,-A Return to an Address to His Excellency the Governor General, dated the 1st May, 1883; praying His Excellency to cause to be laid before this House, a Return showing :-

1. The various articles of food, an analysis of which has been ordered by the Department of Inland Revenue to be made by the Analysit officially appointed for that purpose.
