REGIONAL OFFICES—MINISTERIAL EXEMPTED STAFF

Question No. 699—Mr. Munro (Esquimalt-Saanich):

(a) How many regional offices have been established across Canada staffed by Ministerial exempted staff or by other appointees (b) in what locations (c) what are the names of the officers staffing them (d) from what funds are rent and other office expenses paid (e) what is the cost for each such office?

Mr. Ralph E. Goodale (Parliamentary Secretary to President of the Privy Council): It has been the policy of numerous governments to provide an office and requisite staff for ministers of the Crown in their home communities so that they may continue to function as ministers when they are at home rather than in Ottawa. These are not regional offices—"Regional Office" being defined as one which administers all activities of the department in a particular region—but are supplementary offices intended to expedite the governing of the nation by ministers who reside normally in many different areas of the country. The Minister of Agriculture, as a result of the particularly great importance of agriculture to the western economy, maintains this type of supplementary office in

DREE PROJECTS IN QUEBEC

Question No. 722-Mr. Coates:

- 1. How many specific projects in Quebec has the Department of Regional Economic Expansion been financially involved in since its inception and, in each case, what was the financial involvement?
- 2. Of the total number of projects, what was the estimated employment figure given at the time of the announced involvement of DREE and for those firms still operating, what is the employment figure actually attributable to the financial assistance in each case, as of this date?
- 3. Of DREE's financial assistance to each project, what is the breakdown between outright grants and loans?
- 4. How many of the projects have failed and, in each case (a) on what date was the grant and loan approved (b) on what date did it fail?
- 5. How many employees lost employment as a result of the failure of the project at the date of the closure?

Hon. Marcel Lessard (Minister of Regional Economic Expansion): The reply for the Department of Regional Economic Expansion is as follows: 1. As of October 31, 1976, 2,143 projects in the province of Quebec had accepted offers of financial assistance from DREE under the regional development incentives program. The total value of these incentives offers is estimated to be \$246.0 million. The names of the firms and respective amounts of incentives are available from the reports on the program that are submitted monthly to Parliament.

2. For the 2,143 projects, the estimated employment figure at the time of the announced involvement of DREE was 78,918. Of this total number of projects, 864 were completed as of October 31, 1976. The number of direct jobs actually created at the completion of the control period for these 864 projects, was 29,367 compared to the 31,612 jobs forecasted when the offers of financial assistance were announced. In this context, a "completed project" is one on which the full amount of the development incentive authorized by the minister under the statute has been paid to the applicant. This definition includes (a) a project which has successfully completed its control period, irrespective of any subsequent actions, and (b) a project involving a bankruptcy or total cessation of operations due to fire or other circumstances which requires the department to institute action to recover only part of the incentive paid to the applicant. With respect to this latter type of project, it is to be noted that the statute entitles the
