The Bill was accordingly read a second time; and referred to the Select Standing Committee on Miscellaneous Private Bills, and the 49th and 60th Rules of this House were suspended in reference to the said Bill.

The House resumed the Debate on the amendment to the Question, That Mr. Speaker do now leave the Chair, (for the House again in the Committee of Supply); and which amendment was, That all the words after "That" to the end of the Question, be left out, and the words, "it be resolved That the recent dismissal by the Lieutenant Governor of the Province of Quebec of his Ministry was, under the circumstances unwise, and subversive of the position accorded to the advisers of the Crown, since the concession of the principle of responsible Government to the British North American Colonies," inserted instead thereof;
