or fubstitute, shall sell, barter, or exchange, or deliver upon eredit any Rum, Brandy, Wine, Ale, Cyder, Perry, or other Strong Liquors mixt or unmixt, by whatfover name or names they are or may be called or diffinguished, without Licence first had and obtained for that purpose in manner and form as directed by the faid act, whether tuch child, children, Servant or Substitute, fo fold, bartered, or exchanged, or delivered the fame or not by the Commandment of fuch Father, Mother, Master or Mistress, or shall hawk, sell, or expose to Sale, barter, or exhange or deliver upon credit any fuchLiquors mixt or unmixt, by whatever name or names they are or maybe called or diftinguithed, about the Streets, Wharves, Highways, Lanes, or Suburbs of the Town of Het fax, or any other Town or Place whattoever within this Province, in any manner whatfoever ; or upon the Water in any Ship, Boat, or Vall, or in any other manner whatfoever, or shall deliver upon Credit or tell or barter or exchange, or expose the same to Sale on any Back or Bulks, Stall or Stalls, or in any Shed or Sheds, or on orego any other Place or Places; the Father or Mother of fuch Child or Children, the reputed Matter or Mifficets of fuch Servants or Subflitutes, thall forfeit for every Offence the Sum of Ten Pounds Currency of this Province; and it that and may be lawful for any one Juftice of the Pezee within this Province on his own view, or on Confession of the Party, or by Proof on the Oath of One Credible Witness, to Convict any perion or perions to offending; And the perion or perfons to convicted thall immediately on fuch and every other like Conviction, pay the Sum of Ien Pounds into the hands of fuch Juffice ; and on such Offender or Offenders refusing or neglecting to pay the faid Sum together with the Charges of Protecution, it shall and may be lawful for tuch Juffice to iffue a Warrant under his Hand and Seal, for the levyn gille lame by Diffress and Sale of the Offender's goods and Charger; And if no Sufficient Diffrets can be found then the faid Juffice shall By Warrant under his Hand and Scal, Commit the Offender or Offenders to His Majelly's Gaol within the County where the Offence shall be committed there to remain in close Confinement for the Space of Three Months, or until he or they shall have fully paid and fatisfied the faid Fine and Charge. as aforefaid.

And Where as not with standing the Probibition contained in the faid Act, to restrain persons Selling Spirituous Liquors by Licence in more than one Place under the same Licence, yet sundry persons have presumed to Sell Spirituous Liquors in Two Places under One and the same L cence, contrary to the Intent and meaning of the said Act: Be it therefore surface the factor of the second second second second follows or any of their Children or known or reputed Servants or Substitutes under them, directly or indirectly, shall presume to Sell any Rum, Brandy, Wine, Ale, Cyder, Perry, or other Strong Liquors, mixt or unmixt, by whatsoever Name or Names they are or may be called or diffinguished, by virtue of or under pretence of Licence obtained as in the said Act is directed, in any other Place than at the House or Place where such person or persons themselves shall Bona fide, actually, and constantly reside and dwell; upon Conviction thereof in like manner as aforelaid, fisch person or persons shall be subject and liable to the like
