

KNOWS NOTHING OF WHAT POSITION HE WILL BE ASSIGNED

Lieut.-Col. Delamere, Who Leaves 110th, Still in Dark

PROMOTION IS SLATED

Work at Front and Here Has Won Approval of Seniors.

Lieut.-Col. T. G. Delamere, officer commanding the 110th (Perth) Battalion, who, it was announced in press dispatches from Ottawa appearing in The Morning Advertiser of today, is slated to retire from the command of that unit, knows nothing of his future appointment. For some time it has been rumored that the colonel was in line for a promotion, and the change in the command of the 110th is supposed to confirm this.

Col. Delamere was last night instructed by telegraphic orders to report to Sir Sam Hughes in Ottawa tomorrow. "I know nothing more about the change than this order to report to the minister of militia," declared the 110th D. C. to The Advertiser this morning.

Lieut.-Col. Delamere, an officer of considerable experience, has earned the respect and regard of his men.

He is a veteran of the South African war, where he served with the 2nd C. M. R's. On returning to Canada he settled in Stratford where he was married.

When the present war broke out he offered his services at once, and went to Valcartier in command of the Stratford quota. When his company was sent to the front he was made second in command of the 1st Battalion, who had been promoted to lieutenant-colonel.

When the 110th Battalion was organized he was asked to take command. His work with the present unit has earned the approval of all.

While his old unit still troubles him somewhat it has never interfered with his duties, and it is claimed that he would be well satisfied to return to the front.

While it is not known what appointment he is to receive, military men are of the opinion that it will be a well-deserved promotion.

In the past 24 hours the mercury has been running up and down the tube at a lively rate, fluctuating from 62 last night to 92 at 2 o'clock this afternoon, a change in temperature of 30 degrees in less than ten hours.

The cool nights, followed by hot days, are unusual in Ontario, where the temperature varies as a rule only a few degrees in the 24 hours.

The forecasts are again for cooler weather, with no rain in sight at present. Rain is badly needed in the city. Heavy showers have been reported from other districts.
