FRANCE PREPARES FOR ACTION

Getting Ready to Co-operate With Spain in Quelling the Disturbance.

Beat Way of Amicably Settling International Disputes Discussed At Length.

The Hague, Aug. 3.—The American proposition for the establishment of a permanent court of arbitration at The Hague today achieved success in the peace conference sub-committee that had the matter in hand. Twenty-seven delegates voted affirmatively and 12 abstained.

Chicago, Aug. 3.—Judge Kensaw M. Landis, in the United States district court, fined the Standard Oil company of Indiana \$29,240,000 for violations of the law against accepting rebates from railroads.

American Delegation Lays Proposal Before Peace Conference

The Hague, Aug. 1.—At the peace conference today Mr. Choate, supporting the proposal for the establishment of a permanent court of arbitration, quoted from the letter written by President Roosevelt to Andrew Carnegie on April 5, and read at the international peace congress in New York. He said that the system given to the American delegation were to be selected from different countries, and they represent the systems of law and procedure and the most important languages of the world.

Police Tyranny Leads to Reprisals From Bodies of Workmen

Lodz, Russian Poland, Aug. 1.—This city is again the centre of a strike movement, accompanied by violence, disorders and death. The troops have encouraged the strikers in the centre of the town and some thirty men have been killed or wounded. Business is at a standstill, and fears are entertained as to what the day may bring forth.

War Vessels Sent to Casa Blanca to Discipline the Moors

Paris, Aug. 2.—An extraordinary meeting of the cabinet to discuss the Moroccan situation was held this afternoon. Foreign Minister Pichon expressed himself in favor of immediate energetic action by France to secure reparation for the murder of Europeans at Casablanca and to insure the safety of the Europeans still there. Inasmuch as France and Spain were charged by the Algeiras conference to act together in the matter of policing Casablanca, Mr. Pichon advocated, as a first step, proposing to Spain the immediate landing of French and Spanish troops at the scene of the massacre.

One Hundred Men Killed or Wounded in Conflict in Seoul

Seoul, Aug. 1.—In a conflict to-day at the west gate barracks between Japanese troops and Korean soldiers, forty or fifty were killed and wounded, including several Japanese, who were arrested and imprisoned the Koreans. Firing has ceased. The American consuls were struck by several bullets; no foreigners were injured and the city appears to be safe.
