- 2. That the powers, jurisdiction and authority of the Paper Control Tribunal under the Order in Council of September 16, 1918, (P.C. 2270), should be confirmed and extended as may be necessary to enable said Paper Control Tribunal to finally determine after the declaration of peace all matters pending before and not finally determined by it upon the date of such declaration; and that the powers, jurisdiction and authority of the said Tribunal should be further extended to such extent as may be necessary to enable it to hear and finally determine all matters and questions brought before it subsequent to the declaration of peace on appeal from any act done by or order or decision of the Commissioner and Controller under the provisions of the foregoing resolution.
- 3. That except for the purpose of finally completing all matters undertaken and determining all questions arising prior to the declaration of peace, the powers, authority and jurisdiction of the said Commissioner and Controller of Paper of the said Paper Control Tribunal shall cease upon the declaration of peace.

Resolutions to be reported.

The said Resolutions were reported, read the second time and concurred in.

Sir Thomas White then obtained leave to present a Bill, No. 180, An Act to Provide for the completion after the declaration of peace of work begun and the final determination of matters pending before the Commissioner and Controller of Paper and the Paper Control Tribunal, or either of them, at the date of such declaration, which was read the first time, and ordered for a second reading at the next sitting of the House.

The amendments made by the Senate to the Bill No. 95, An Act to assist Returned Soldiers in settling upon the Land, were taken into consideration and respectively agreed to.

The Bill No. 166, An Act to constitute a Board of Commerce for Canada, was again considered in Committee of the Whole, and further progress having been made and reported, the Committee obtained leave to consider it again this day.

A Message was received from the Senate informing this House that the Senate accedes to the request of the House of Commons for a free conference to consider the Bill No. 107, An Act to confirm the Order in Council of the twenty-fourth day of February, 1919, prohibiting the Importation, Manufacture and Transportation of Intoxicating Liquors, and the Order in Council of the twelfth day of April, 1919, in amendment thereof, and any amendments which at such conference it may be desirable to make thereto, and have appointed the Honourable Messieurs Bostock, Power, Lougheed, Sir James, McMeans, Michener, Pringle, Ross (Middleton), and Thompson, as Managers on their part at said free conference.
