RUSSIA-FURTHER WHEAT PURCHASES AND CREDIT ARRANGEMENTS REQUESTED

On the orders of the day:

Right Hon. J. G. Diefenbaker (Leader of the Opposition): In the absence of the Minister of Trade and Commerce I should like to ask the Prime Minister if there is any foundation for the newspaper article to the effect that to all intents and purposes no immediate future purchases of wheat will be made by the U.S.S.R.; and whether it is a fact that the U.S.S.R. has asked Canada, should it desire to extend its trade in the U.S.S.R., for credit arrangements extending between 10 and 15 years.

Right Hon. L. B. Pearson (Prime Minister): I will be discussing this matter with the minister on his return tomorrow, and perhaps he will be in a position to give an answer to the question. Of course he has already said in the house that there has been no definite information from the Soviet union as to whether they will or will not be importing more wheat from Canada.

So far as the latter part of the question is concerned, I have ascertained, as no doubt my right hon. friend has, that the Soviet union has been making statements of this kind to a good many governments in regard to providing credit terms.

Mr. Diefenbaker: Has the U.S.S.R. stated to Canada that it desires, indeed demands, credit arrangements of between 10 and 15 years in respect of any future trade?

Mr. Pearson: No. we have had no official demand or request of that kind from the U.S.S.R. in regard to credit terms.

MINES AND TECHNICAL SURVEYS

WINTER BERTHING OF HYDROGRAPHIC SHIP "ACADIA"

Hon. W. M. Benidickson (Minister of Mines and Technical Surveys): Mr. Speaker, on Friday last the minister from Pictou asked-

Some hon. Members: Oh, oh.

Mr. Benidickson: -the hon. member for Pictou asked if I had received a communication from the board of trade of Pictou regarding the berthing of the Canadian hydrographic ship Acadia. I said, and it proved to be correct, that nothing of that kind had at that time come across my desk, although I had had representations the previous year. I find that late on Wednesday a communication was received from the board of trade of Pictou. I was away in Quebec city on Thursday, and my staff proceeded to make inquiries concerning plans for the berthing of this ship this winter.

I gave consideration to the representations that have been received from my hon. friend, from the Minister of Labour and others, and over the week end we have decided to continue the winter berthing of the Acadia at Pictou. It has been berthed at Pictou since 1945, although with the establishment of the oceanographic institute at Halifax there are some operational advantages in the ship being berthed in a port that provides a longer operational season. I assure my hon. friend, however, that the arrangement will not be disturbed this winter.
