"WEEKEND" PROGRAM, "LAW AND ORDER—PRAIRIE STYLE"

Question No. 1,267—**Mr. Dinsdale:**

1. Has CBC or CRTC received any complaints or commendations with respect to the "Weekend" program for February 1, 1970, entitled Law and Order—Prairie Style?

2. How many complaints were made, by whom and what was the nature of the complaints?

3. What action has been taken by (a) CRTC (b) CBC?

Hon. Gérard Pelletier (Secretary of State):

I am informed by the Canadian Broadcasting Corporation and the Canadian Radio-Television Commission as follows: 1 and 2. The CRTC received one unfavourable comment referring to certain alleged inaccuracies. The CBC received 8 favourable and 18 unfavourable comments. The unfavourable comments came from a number of individual viewers, the Regina Chamber of Commerce and the Regina Responsible Citizens Committee. The complaints varied but basically contended that the subject was not given a fair presentation.

3. (a) The CRTC noted the observations and referred the complaint to CBC which is normal practice where there is no clear evidence of infraction to the Broadcasting Act or regulations. (b) The reaction was made known to the program people of the CBC directly concerned.

CONVERSION OF COLLEGE ST. JEAN,
EDMONTON, TO FRENCH LANGUAGE

Hon. Gérard Pelletier (Secretary of State):

1. Last summer, before the announcement of the proposals of the federal government concerning cooperation with the provinces with respect to bilingualism programs in the field of education, the Secretary of State Department received an enquiry from the Department of Education of Alberta concerning the possibility of making use of the College St. Jean in Edmonton as a centre for the training of bilingual teachers in the West. Subsequently, the government announced proposals concerning cooperation with the provinces on November 6. Since then the Under-Secretary of State has written to the western provinces seeking their views on the matter of a teacher training institute for the West. Provincial comments have not yet been received.

CANADA COUNCIL RESEARCH GRANT TO

Is Professor William Morrison of the University of Manitoba in receipt of a Canada Council research grant and, if so (a) what is the amount of the grant (b) what is the nature of the research (c) will the results of Professor Morrison's research be published?

Hon. Gérard Pelletier (Secretary of State):

I am informed by the Canada Council as follows: Yes. (a) \$2,500. (b) Prof. Morrison, a sociologist working in cooperation with the departments of psychiatry of the Manitoba School of Medicine and the Winnipeg General Hospital, conducted a scientific inquiry on the social characteristics and the attitudes of women engaged in prostitution. (c) Not known. While the Canada Council expects recipients of its Research Grants to make the results of their research known to other scholars, it is the researcher who chooses the means of doing so.
