The application was rejected for the following reasons: The number of participants, fifteen, did not seem justified for the project's proposed activities (a recreation program in a small community). In 1972, the average number of paid participants per project was 8.3. In addition, the project's proposed administrative expenses were well over the 10 per cent of the total salaries budget normally allowed.
