LEVEL OF FUNDING FOR EMPLOYMENT AND IMMIGRATION COMMISSION AND FOR PRIME MINISTER'S OFFICE—MOTION UNDER S.O. 43

Mr. Stan Darling (Parry Sound-Muskoka): Madam Speaker, I rise on a matter of some urgency under the provisions of Standing Order 43. Restraint and equity were two of the main themes of last November's disastrous budget. The tabling of the 1982-83 spending estimates demonstrates that the government has no intention of practising either. Despite the fact that there are more than 1.5 million Canadians unemployed, the budget for the Canadian Employment and Immigration Commission will only increase by 6.6 per cent, in contrast to a 24 per cent increase in the funds being provided to run the

office of the Prime Minister (Mr. Trudeau). I move, seconded by the hon, member for Prince Edward-Hastings (Mr. Ellis):

That the Prime Minister, in the spirit of restraint and equity, take immediate steps to reverse either the percentage of increase with respect to his office and the employment commission, or use his additional funds to hire unemployed Canadians who obviously have a sound, first-hand understanding of the state of our economy.

GARRISON DIVERSION

SUGGESTED VISIT BY CANADIAN PARLIAMENTARIANS TO WASHINGTON—MOTION UNDER S.O. 43

Mr. Charles Mayer (Portage-Marquette): Madam Speaker, the International Joint Commission, in a report on the Garrison diversion project in 1977, recommended that "those portions of the Garrison diversion unit which could affect waters flowing into Canada not be built at this time". Subsequently the House unanimously passed a motion on March 5, 1981, supporting the thrust of the decision of the International Joint Commission. Until recently the only thing preventing continued construction on the Garrison was a court injunction obtained by a private group of Americans. Therefore I move, under the provisions of Standing Order 43, and seconded by the hon. member for Lisgar (Mr. Murta):

That the federal government support the suggestion that was made to the Secretary of State for External Affairs in the House on November 19, 1980, to send an all-party delegation of members of the House to Washington to the American legislators know that Canadians are unalterably opposed to construction of those sections of Garrison which will cause damage to Canadian waters.
