Some Hon. Members: Hear, hear!

Mr. Speaker: Order, please. Perhaps the Hon. Member for Winnipeg—Birds Hill could put his supplementary question.

Mr. Blaikie: I was waiting for an answer to my question, Mr. Speaker, but it looks as though that will not be forthcoming.

PRIME MINISTER'S POSITION

Mr. Bill Blaikie (Winnipeg—Birds Hill): Mr. Speaker, my supplementary question is directed to the Prime Minister. Given the fact there is amassed evidence to the effect that his senior Minister in his Government broke the rules, what kind of signal is the Prime Minister sending to all those communities which applied for funding for such projects and need jobs every bit as much as Edmonton, and some of which need them more, and did not get this kind of funding?

In connection with next summer's employment structural reorganization of the Department of Employment and Immigration, the Minister assured me that the Drummondville district regional office would not be closed as a result of the reorganization. Is he now in a position to confirm this so as to reassure my constituents and the Drummond federal office staff?

Hon. Benoît Bouchard (Minister of Employment and Immigration): Mr. Speaker, the restructuration of employment centres and employment development centres is a nationwide project. Far from being complete in Quebec, it is still under way and any information to the effect that we intend to close Drummondville's district centre is unfounded. No such decision has been made concerning restructuration in Quebec.
