He said: Mr. Speaker, I would like to thank the House for its co-operation, which allowed me to present this motion on behalf of the member for Winnipeg North, who was unable to return to Ottawa for the debate today.

This motion is to create an independent board, a board that will meet at least once a year to discuss matters of importance with respect to the operation of the agency. It is unfortunate that the board, although it is created for good reason, is there and left only to meet at the bequest of the minister whenever he happens to feel so inclined. The intent of the motion is to ensure that at least once per year this board convenes.

In addition, this provides me the opportunity to make some brief comments on the agency, and to express our concern that it has taken so long to finally come to the point where this agency is coming into existence. We hear so often of the government's concerns about financial matters and deficits, that we sometimes wonder whether its entire policy is not driven by fear of the deficit. Here is a very worth—while proposition that, when it is created, is going to streamline some government operations.
