# FEDERAL-PROVINCIAL FISCAL ARRANGEMENTS AND FEDERAL POST-SECONDARY EDUCATION AND HEALTH CONTRIBUTIONS ACT

## MEASURE TO AMEND

The House resumed from Monday, March 9, consideration of the motion of Mr. Mazankowski that Bill C-60, an act to amend the Federal-Provincial Fiscal Arrangements and Federal Post-Secondary Education and Health Contributions Act, be read the second time and referred to the Standing Committee on Finance.

**Mr. Murphy:** Mr. Speaker, I am seeking clarification. It was my understanding that we were going to Bill C-52 at this point. I know what you have called, I would just—

**The Acting Speaker (Mr. DeBlois):** I remind the hon. member that the projected order of business is subject to change without notice. It is the order of the day. I have no option than to take note of that bill.

**Ms. Mary Clancy (Halifax):** Mr. Speaker, it is with a certain amount of chagrin that I rise to speak on this bill because there have been so many occasions when I have spoken in this House on this very matter.

This bill is an act to amend the Federal-Provincial Fiscal Arrangements and Federal Post-Secondary Education and Health Contributions Act.

Those are two areas that most particularly in my province of Nova Scotia we are having some difficulties with. I represent, as most members of this House know, the city of Halifax. Within the larger area of the city, my riding and the riding of Halifax West, we have five universities. These are respected and historic institutions of higher education and learning.

We have indeed in the city of Halifax the oldest university in the British Commonwealth outside the British Isles, that being the University of King's College.

We have the largest university in Atlantic Canada with professional schools famous world-wide, Dalhousie University. We have the only women's degree-granting institution in the British Commonwealth of Nations, Mount St. Vincent University. We also have the Nova Scotia College of Art and Design, the Atlantic School of Theology, and of course, St. Mary's University.

Every one of those institutions is suffering. Our universities across the country are suffering, but most particularly in the Atlantic region. We are suffering from the highest tuition fees in the country from the oldest physical plants and from the lowest salaries to our faculty and staff.

There is a great and historic tradition in the province of Nova Scotia with regard to higher education. Indeed, we say with pardonable pride in Nova Scotia that it is graduates of our institutions who have gone across this country to staff other universities.
