Some time during the next month or so an important special meeting of the board of regents of Mount Allison will be held to consider the appointment of a successor to Dr. Allison as president of the university.

The resignation is to take effect not later than at the close of the coming college year, but if the board is able to secure a successor before the end of the year Dr. Allison will retire when such a man is prepared to take up the duties of the position.
