MILLS, Hon. DAVID, LL.B. (*Bothwell.*)

Family, which came from near Plymouth, Eng., proceeded to Holland in the time of Charles I., thence to New England with the Puritans, and the descendants removed to N.S. at the time of the Am. Revolution. S. of Nathaniel Mills, who removed from U.S. to Can. 1817. B. in the Tp. of Oxford, Kent, Ont., 18 March, 1831. Graduated at Michigan Univ. M., Dec. 1860, Miss M. J. Brown. Called to the Bar, Ont., 1883. Was Superintendent of Schools for Co. of Kent, from April 1856 to April 1865. Was employed by Ontario Govt. to define the North-western Boundary of the Prov. 1872, and was one of the counsel employed in the argument before the Privy Council in Eng. in 1884. Author of a pamphlet on *The Present and Future Political Aspects of Canada* (1860); and another on *The Blunders of the Dominion Government in connection with the North-West Territory* (1871.) Elected a mem. of the (Council of Public Instruction for Ont. (representing the School Inspectors) Aug. 1875. Sworn as Minister of the Interior, Oct. 1876, which position he held until resignation of Govt., Oct. 1878. An unsuccessful candidate for a seat in the Council of Public Instruction, Ont. 1874. First returned to Parl. at g.e. 1867; re-elected at g.e. 1872; at g.e. 1874; at g.e. 1878; defeated at g.e. 1882, but subsequently awarded the seat by the judgment of the Supreme Court of Canada. Re-elected at last g.e. An advanced Liberal.—*Palmyra, Ont.*

MILLS, JOHN BURPEE. (*Annapolis.*)

Youngest s. of John Mills, Esq., merchant and ship-owner, Granville Ferry. Ancestors came from Yorkshire, Eng., and settled in N.S. about 1770. B. at Granville Ferry, 24 July, 1850. Ed. at Acadia Coll., Wolfville, N.S., graduating B.A. with Honors in 1871. Received degree of M.A., 1877. M., 23 Oct., 1878, Bessie, second dau. of A. W. Corbitt, Esq. Attended the Law Sch. at Harvard Univ. for one year, and was called to the Bar, N.S., 1875. Was a mem. of the Municipal Council of Annapolis from
