2. Bill to amend Act 40 Vic., c. 10, intituled: "An Act to amend and consolidate the Acts respecting the Customs" (Mr. Bowell); Ordered; Presented, 250. Read second time; Committed; Amended; Considered; Passed, 286. By the Senate, with an amendment; Considered; Agreed to, 336. R.A., 389. (44 Vic., c. 11.)

**D**EBATES:

1. Select Committee appointed to supervise the Official Report of the Debates, 45. First Report recommending addition of Mr. F. R. Marceau to Reporting Staff at a salary of \$1,000, 167. Concurred in, 168. Second Report, recommending an appropriation of \$5,000 for extra expenditure; also the continuation of contracts for printing, &c., of Debates during next Session; also the retention of Mr. Marceau on the Reporting Staff; and also that more suitable rooms be provided for the accommodation of the Reporting Staff, 338. Concurred in, 373. Third Report, recommending that each Reporter on Official Staff, be allowed to employ an amanuensis at twelve dollars per week; also submitting a communication laid before Committee by Official Reporters, 373. Concurred in, 387.
2. Motion by Mr. MacDonnell (Inverness), That in view of the yearly increasing cost to the country of the Sessions of Parliament, &c., the official reporting and publication of the Debates of the House be discontinued, 272. Motion in amendment, That there be only published in the *Hansard* a synopsis of the speeches delivered. Motion in amendment to the amendment, That speeches be reported *verbatim et literatim*, no time being given for alterations and corrections, and that no member be allowed to speak more than one hour without the consent of the House; Withdrawn; Amendment and Main Question negatived, 273.
