Then, the Question, so amended, being put:—It was resolved in the Affirmative.

Mr. Ross (Champlain) moved, seconded by Mr. Archambeault, That the Bill be further amended by leaving out the word "Quebec" and inserting the words "Three "Rivers" instead thereof; the House divided: and the names being called for, they were taken down, as follow:

A Bill to amend chapter fifteen of the Consolidated Statutes for Lower Canada,

respecting Public Education, was, according to order, read the third time.

On motion of the Honorable Mr. Solicitor General Langevin, seconded by the Honorable Mr. Solicitor General Cockburn, the Bill was amended by adding the following Provise at the end thereof, "Provided always, that nothing in this Act shall have the "effect of authorizing possession to be taken of any property held by a fabrique, church, body, corporation or association for religious or scholastic purposes."

Resolved, That the Bill do pass.

Ordered, That the Clerk do carry the Bill to the Legislative Council, and desire their concurrence.
