

FRIDAY, February 4, 1825.

THE House met pursuant to adjournment.—PRAYERS.

On Motion the Bill intituled “an Act for summary punishment in certain cases of persons wilfully or maliciously damaging or committing Trespasses on public or private property,” received the second reading.

On Motion the House resolved itself into a Committee of the whole House, to take into consideration the said Bill,

Mr. Speaker left the Chair,

The Attorney General took the Chair of the Committee,

Mr. Speaker resumed the Chair,

The Attorney General Chairman of the Committee reported, That they had gone through the Bill and agreed to the same with an amendment.

Ordered, That the Report of the Committee be agreed to.

By Order, Mr. *M'Neill*, carried to his Majesty's Council, the following Bills for their concurrence, viz.

A Bill for establishing an Assize of Bread within the Town and Royalty of Charlotte-Town, also,

A Bill to regulate the duties and charges of Pilots within this Island.

By Order, Mr. *M'Gregor*, carried to his Majesty's Council, the Bill intituled “an Act to regulate the Fisheries of this Island,” for their concurrence.

On Motion, the Bill to prevent the running at large of Sheep in the Town and Royalty of Charlotte-Town, received the second reading.

On Motion, the House resolved itself into a Committee of the whole House, to take into consideration the said Bill,

Mr. Speaker left the Chair,

Mr. *M'Neill* took the Chair of the Committee,

Mr. Speaker resumed the Chair,
Mr. *M'Neill*, Chairman of the Committee reported, That they had gone through the Bill and agreed to the same with amendments, and an alteration in the title, which is as follows, viz. a Bill to prevent the running at large of Sheep in the Town of Charlotte-Town.
