AMERICAN MARKETS.
CHICAGO, Dec. 21.—Wheat was built up, influenced by cables and a reviving foreign demand, and imparting its strength to other markets brought higher prices. May wheat closed 4½ higher. May corn ½ up, and May oats ¼ higher. Provisions closed 2½ to 3½ higher. Local receipts of wheat were only 14 cars, 1 of contract grade; Minneapolis and Duluth receipts 20 cars against 464 a week ago and 524 last year. Seasonable clearances in wheat and flour equaled 200,000 bu. Primary receipts were 64,000 bu. against 74,000 bu. last year. Estimated receipts for Monday: Wheat, 23 cars, 215 cars; oats, 120 cars; hogs, 46,000 head.
