

MAYOR WANTS JUVENILE COURT OPEN ON MAY 1ST

WENIG RESENTS WORDS CREDITED TO PHILIP POCOCK

Douglas and Drake Also Are Aroused Over Remark on Railway Purchase.

VOTE OF PEOPLE

State Bus System Would Cost No More Than Arbitration Proceedings.

Mayor Wenig and Ald. Leonard Douglas, chairman of the board of works, have started in pursuit of Commissioner Philip Pocock, who has been credited with statements to the effect that "No Britisher would want to violate the city's agreement with the street railway company and oppose the purchase of that corporation."

"Commissioner Pocock is stepping pretty close to the line, and he had better be careful with his remarks," Mayor Wenig declared at noon today. "He talks about Britishers. Well, I want to challenge him if a 439 property owner of London who voted at the last municipal election against the purchase of the street railway company are not as good Britishers as he is."

Good Britishers.

"Does he mean that they are not British just because they exercised their franchise? I'll tell him that they are as good Britishers as he is, and that they voted against the purchase of the street railway company, despite the vast amount of propaganda that was let loose at that time when there was no argument presented against the purchase of the road."

It is Ald. Douglas' belief that Commissioner Pocock's remarks have been mightily close to the line. "He practically intimates that those who were urging the inauguration of a motor-bus system are expelling graft of some nature," he commented. "I would ask how about those people who are supporting the purchase of a street railway system that is rotten, without telling the people that the price will be or even going to the company last year and asking for a figure."

Supports Bus Scheme.

"Can these same people say as truthfully that they have no personal interest in the outcome. I contend that Commissioner Pocock's remarks recently have convinced scores more citizens that the motor-bus scheme is the right one."

"Commissioner Pocock had better be careful with his language," Mayor Wenig added. "He knows all about hydro affairs, but he knows but little about city council affairs."

"Does he ever ride the street cars?" questioned Ald. Leonard Douglas. "Does he believe that he ever does?"

"Does it look right," also questioned Mayor Wenig, "that these people should be the ones to buy the street railway while the people are not to be told what the price shall be. It may be that somebody wants a good fat arbitration job at \$250 a day."

Drake Aroused.

"What's the matter with Commissioner Pocock? Has he a share in the London Street Railway?" This is the question from Ald. Gordon Drake, who voices unfeigned surprise with the remarks attributed to that member of the public utilities commission.

"I am certainly surprised," commented Ald. Drake, "that a man of Mr. Pocock's ability and business experience should expect in honoring people of the city to walk and endure such transportation as we have."

"Why, we could put in a motor-bus system for the money that he expects for arbitration proceedings. In any event, let's have transportation."

EXPECT OFFER OF SITE WILL NOT BE ACCEPTED

Trustees Feel School Should Not Be Designated as Memorial.

From opinions expressed today by various school trustees, it is highly probable that the board of education will refuse Dr. H. T. Reason's offer for a free site for the new school in West London.

The trustees interviewed had the one objection in common and that concerns the condition which Dr. Reason has attached to the offer.

Dr. Reason has expressed his willingness to give three or four acres of land to the board free of charge, providing that the new school will be officially named the "Catharine Reason Memorial School." The site would be a part of 34 acres forming the Reason estate located west of Wharncliffe road.

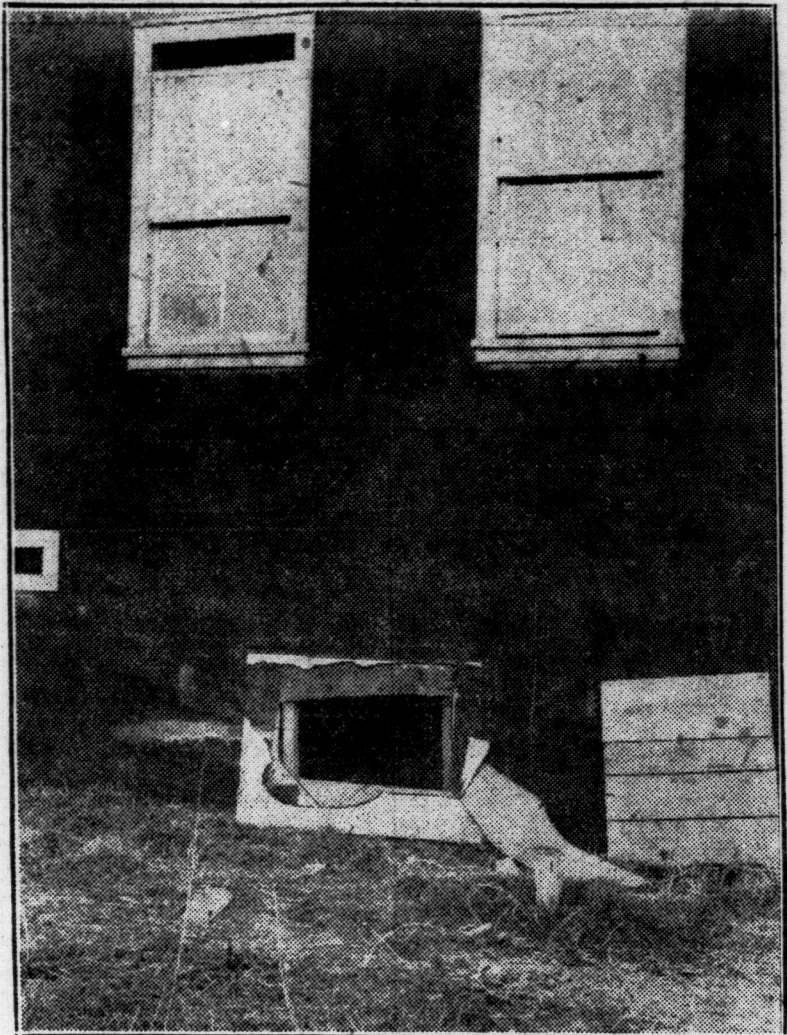
The majority of the trustees and the school officials, feel that it would be a step in the wrong direction to designate a school building as memorial for a monetary consideration.

They see no objection to the naming of a school in recognition for public service as was the case with the Memorial named in honor of the late J. B. Boyle, who served as public school inspector for a great many years and who died in his office. They do not think, however, that such honors should be sold.

The matter has not come before the board officially as yet for there was no time at the special meeting held Monday. The trustees as individuals, however, have studied the offer. A meeting of the property committee will be held in the near future to consider the various sites under consideration.

Two Boys Build Bonfire Underneath C.P.R. Bridge

Truants Are Very Much Surprised When Bridge Catches Fire—Pay Visit to Police Court Today.

The feat of two school boys, who played hookey last week and then stole eggs, was surpassed yesterday by the adventures of two other truants who set fire to a bridge over the C. P. R. on the Asylum sideroad. Sunshine and soft winds tempted the two boys, both of whom were 14 years of age, to leave their classrooms at the Technical School and steal away to the country.

When in the open country east of the city, however, the boys were found to be much colder than the young adventures expected them to be, and so they crept beneath the overhead railroad bridge for shelter. Dried grass, leaves and sticks were there in abundance, and the boys had matches. The immediate result was a bonfire.

Fortunately the fire did not reach the floor of the bridge, and much to the young truants' consternation, the fire was extinguished. The station agent, who lived nearby, and he phoned to the London East yards. Soon an engine had reached the scene, and with water, drawn from the tanks, the flames were extinguished before a great deal of damage was done.

The boys did not escape as lightly as the truants of last week, for this morning they were summoned before Magistrate Graydon in police court. They were allowed to go on suspended sentence, but they will be forced to leave the Technical School and go back to public school.

A third boy played truant from a public school and stole a bicycle from the school yard, which he rode all afternoon and then hid away.

The owner of the wheel afterwards learned where the wheel was hidden and secured its return. This morning the boy was apprehended by Dr. George Weir, attendance officer, who took him before Magistrate Graydon. It is likely that he will be sent to some industrial school.

NO ACTION IS TAKEN ON BRITAIN REPORT

James Gray Denies He Said New Hospital Head Would Be Appointed.

Members of the hospital trust have taken no action as yet to carry out recommendations made in Dr. Britain's report of Victoria Hospital.

James Gray, chairman of the board, denied a report circulated by a local paper yesterday that he had said a new general superintendent would be appointed at the hospital.

"I cannot say what will happen," he informed The Advertiser this morning. "First of all, the trust will have to consider the recommendations carefully before deciding on any action. I did not say yesterday a new head would be employed for the institution."

In Dr. Britain's report there is a recommendation that a new general superintendent should be employed. Dr. Britain stipulated that he should be a man capable of co-ordinating all departments and to restore order and authority to all whom authority belongs.

A prediction that a new superintendent would be employed was made in The Advertiser some weeks ago.
