POSSIBLE TRANSFER OF HOSPITALS FROM FEDERAL CONTROL

Hon. D. S. Harkness (Calgary North): Mr. Speaker, I should like to direct a question to the Minister of Veterans Affairs. Is the minister in a position to inform the house of the outcome of the talks which were being held with the Alberta provincial authorities in connection with the Colonel Belcher hospital in Calgary?
