- 5. Has the group insurance been divided or farmed out one-third to the John Hancock Mutual Life Assurance Company of Boston, one-third to the National Life Company of Canada and one-third retained by the Maritime Life Assurance Company of Halifax?
- 6. If these are not the correct figures, has the group policy been farmed out and on what basis?

Hon. Léo Cadieux (Minister of National Defence): 1. No. Members of the Canadian Forces designed a self-paid group insurance plan for the specific needs of the serviceman. The Chief of the Defence Staff will sign the contract on behalf of the serviceman. The expenditure of public funds is not involved in this proposal.

- 2. The value of the insurance and the premiums are individual based on age, income, family status and years of service. Since it is a vountary program the number of participants cannot be forecast and thus the aggregate amount of protection is unknown.
- 3. The plan was offered to all federally registered insurance companies. A consortium, of which Maritime Life Assurance Company of Halifax was a member, was eventually accepted.
- 4. John Hancock Mutual Life Assurance Company of Boston is the principal shareholder of Maritime Life Assurance Company of Halifax.

- 5. This insurance plan is co-insured by the three companies quoted in equal amounts. Maritime Life Assurance Company, is a member of the consortium, will be operating and administering the plan.
