Air Canada management advises: The current domestic fares structure for normal or regular fares is based on the following formula: Routes of 1,100 Miles or Less; \$12 plus 5.8 cents per mile; Routes of Over 1,100 Miles; \$13.50 plus 6.0 cents per mile for the first 500 miles; \$13.50 plus 5.5 cents per mile for the next 500 miles; \$13.50 plus 5.0 cents per mile for the next 500 miles; \$13.50 plus 4.5 cents per mile for the remaining miles.

Selecting points at random in the areas requested, this formula produces the following fares and rates per mile:

- 3. Yes, providing they meet the requirements of the Canada Shipping Act and the Coasting Trade Regulations.
