CONDEMNATION OF OFFICIALS' ACTIONS

Mr. Doug Lewis (Simcoe North): Mr. Speaker, it is a sad day for Canada when taxpayers' funds are used by the Office of the Prime Minister (Mr. Trudeau) for a personal witch hunt.

MALAWI—APPEAL FOR COMMUTATION OF DEATH SENTENCES IMPOSED ON FORMER JUSTICE MINISTER AND WIFE

The Chirwas were convicted in July, 1982, of treason by the Regional Traditional Court. They insisted that they were innocent. They appealed to the National Traditional Court, which upheld the sentence of the lower court. Amnesty International has stated that procedures of these courts did not
