In witness whereof, I have hereunto set my hand this 27th day of January, in the year of Our Lord, 1983, and of the Independence of the United States of America the 207th.

Canada did not follow the President's example in 1983. However, may I suggest that this Parliament proclaim a day of prayer in Canada in early 1984, a day on which we might all pray for world peace and brotherhood.

## CORPORATE SHAREHOLDING LIMITATION ACT

**GOVERNMENT POSITION** 

Mr. Brian Mulroney (Leader of the Opposition): Mr. Speaker, in the absence of the Minister of Consumer and Corporate Affairs, my question is directed to the Acting Prime Minister. Last Friday, the Minister said that the Liberal caucus unanimously supported Bill S-31. Is that still the case and does the Minister intend to proceed with consideration of this Bill?

Hon. Marc Lalonde (Minister of Finance): Mr. Speaker, the Minister of Consumer and Corporate Affairs will be here in a few minutes, but I can inform the Leader of the Opposition that the caucus has examined this matter and has made suggestions to Cabinet. Bill S-31 is now before the Senate, and since the House intends to adjourn shortly, it stands to reason we will not be able to consider and pass this Bill before the end of this session. The caucus—

Some Hon. Members: Oh, oh!

Mr. Lalonde: I wonder why my hon. colleagues opposite are so surprised, because they know perfectly well we intend to start a new session very shortly, and that this Bill, like so many other Bills that are before the Senate or before the House, may not be considered by the House before the end of this session. Regarding the legislative program for the next session, the Leader of the Opposition will have to wait until the program is announced. However, as the Hon. Leader of the Opposition is aware, Members of the Quebec caucus have suggested that before proceeding with a new Bill during the next session, there should be further consultation with business and the Provinces.

Mr. Mulroney: I assume, Mr. Speaker, the Minister meant to say no.

Since the Minister of Consumer and Corporate Affairs is now in the House, as far as Bill S-31 is concerned, the Oral Questions

Member for Longueuil said this morning, and I quote: "Bill S-31 is already dead."

Considering this very straightforward statement, does the Minister intend to let the Bill die on the Senate Order Paper or does she intend to proceed with this legislation?
