#### **OLD AGE SECURITY**

FULL INDEXATION OF PENSIONS—GOVERNMENT POSITION

Mr. Jean-Claude Malépart (Montreal-Sainte-Marie): Mr. Speaker, to hear our new Robin Hood, 1985 version, who takes from the poor to give to the rich, he wants to get rid of the elderly altogether. My question is directed to the Prime Mnister, Mr. Speaker.
