Hon. Herb Gray (Windsor West): Point of order.

Mr. Speaker: I hope the Hon. Member for Windsor West (Mr. Gray) is rising on the business question and not on this point of order because he knows I cannot allow this to become a debate, with respect.

Mr. Ouellet: It's a reflection of the quality of the answers we are getting.

Hon. Herb Gray (Windsor West): Mr. Speaker, when you consider this particular point, I would appreciate you also considering whether it is parliamentary for the Minister of Transport (Mr. Mazankowski) to have said that an Hon. Member on this side misled the House and then went on to say "maybe it was not deliberate". It would seem to me that in order to use the word "misled" in the way which is acceptable, the person using it must make clear he does not suggest it was used deliberately, without equivocation.

Mr. Siddon: That's what he did.

Mr. Ouellet: He said "maybe".

Mr. Speaker: Order, please. The Hon. Member is in fact raising a different point of order about another Hon. Member's language. I listened very carefully to what the Minister—

Some Hon. Members: Oh, oh!

Mr. Speaker: Order, please. Perhaps all those involved, including Ministers and backbenchers, would please stop this. I listened very carefully, as I did earlier to the Hon. Member for Oshawa (Mr. Broadbent). I had some difficulty in knowing what was being said in that situation which is why I intervened. I listened very carefully because I think the Chair tries to hear people as being in order. I think that is the Chair's intention. So I listened to what the Hon. Minister said and it seemed to me he very carefully tried to indicate that if an impression was left that he was accusing someone of something unparliamentary he wished it to be withdrawn. That is what the Chair took from the Minister's language at the time. However, that is the dilemma the Chair is always in when interpreting language, which is why the Chair rose earlier where it was not clear to ask that it be made clear.
