

**HEAVY STEERS ARE
READILY BOUGHT**

Ten Carloads on Market Yesterday Soon Picked Up.

PRICES WERE BETTER

Receipts in Cattle Were Light and Lambs Were Lower.

The receipts of live stock at the Union Stock Yards on Friday numbered 40 carloads including 563 cattle, 58 calves, 335 hogs and 1402 sheep and lambs.

About ten cars of the cattle receipts were heavy steers, and were all absorbed by local buyers at prices ranging from \$14.00 to \$18. According to quality, this class sold stronger than Friday a week ago, probably 10 to 15c. Good choice butchers weighing 600 to 1150 lbs., sold at a shade stronger than in the early part of the week—\$17.50 to \$18.00. Medium sold at from \$16.25 to \$17.50.

Lambs—Nearly all the lambs showing were of the heavy kind, and the trading closed 25c to 40c lower than last week. Light lambs were easier also, but the choice quality were absent.

Hogs—Prices were quoted at \$3.75 to \$4.00. BRADSTREET'S TRADE REVIEW.

Toronto reports to Bradstreet's that the process of recovery in agricultural, industrial and commercial Canada continues to be a good one. A good barometer of labor conditions is the barometer of charity institutions in cities. In recent cities, and especially in Toronto, expenditures have been cut down to meagre proportions, because it is not needed. There is plenty of employment in industrial establishments, and on farms. The unprecedented crops in Canada, and the needs of war are at the back of the improved conditions. Both east and west money is in freer circulation, general buying power has been materially enhanced and the result is being felt in a large volume of business in almost all staple normal. The grocery trade continues to be active. The volume of placing orders and sorting orders in wholesale dry-goods houses continues on the increase, and the expansion latterly has been noteworthy. Hardware firms are doing better now. The movement from retailers' shelves has forced them to purchase. Settlements from eastern and central Canada have been good, although from the west, while they improve, remittances are still backward. Sugar advanced in Toronto 25 cents per hundredweight. Milling companies with local offices report capacity operations. Textile firms are actively engaged in filling orders. Industrial concerns have received new shell contracts.

WINNIPEG GRAIN MARKET.

WINNIPEG, Nov. 12.—Trading generally was less active today, and prices were steady. Wheat closed unchanged to 1c up; oats closed 1/2c to 1c higher, and flax closed 1/2c to 1c up.

The wheat market started 1/2c to 3c higher, influenced by firm Liverpool cables. Later market declined on report of demand and little speculative buying. Oats opened 1/2c to 1c higher, and held steady. Flax opened 1/2c to 1c higher, and weakened later.

Cash demand for wheat was not so great as recently, and premiums paid in the early hours were 2 1/2c over November for No. 1 northern.

Oats and barley held steady, with a fair demand. Flax in good demand.
