A YOUNG MAN MURDERED HIS MOTHER'S PARANOIA.

A verdict of Willful Murder with Extenuating Circumstances by the Coroner's Jury—The Whistler—Moore's Account, Cont.

LONDON, Sept. 18.—Planned is now the scene of a sensational murder case, the developments of which are being followed by Londoners with much interest. This is the affair of young William Lyons, who last Friday night stabbed and killed his mother's paranoiac, (nephew) in a room at the Victoria Hotel, in a street in the Strand.

The coroner's inquest, which opened on Monday, was held in the Strand, and was attended by a large number of witnesses, including the mother, the young man, and the police.
